Notice is hereby given that by an order dated 20 June 2019, the Hyderabad Bench of the National Company Law Tribunal (“**Tribunal**”) has directed a meeting to be held of the Unsecured Creditors of the Transferor Company for the purpose of considering, and if thought fit, approving with or without modification, the proposed Scheme of Amalgamation between the Transferor Company and Zuari Cement Limited and their respective Shareholders (“**Scheme**”).

In pursuance of the said order and as directed therein further notice is hereby given that a meeting of the Unsecured Creditors of the Transferor Company shall be held at Sitapuram Works, Administrative Building, P.O. Dondapadu, Nalagonda – 508426 on 3 August 2019 at 11 AM at which time and place the said Unsecured Creditors of the Transferor Company are requested to attend to consider and if thought fit, approve with or without modification(s), the resolution set out below in this Notice under Sections 230 to 232 of the Companies Act, 2013 and other applicable provisions, if any, of the Companies Act, 2013, read with the rules framed thereunder (including any statutory modification(s) or re-enactment thereof for the time being in force).

“**RESOLVED THAT** pursuant to the provisions of Sections 230 to 232 and other applicable provisions, if any, of the Companies Act, 2013, other applicable enactments, rules, regulations and guidelines, Memorandum and Articles of Association of the Company and subject to the sanction by the National Company Law Tribunal, Hyderabad Bench (“**Tribunal**”) and subject to other approvals, permissions and sanctions as may be necessary and subject to such conditions and modifications as may be prescribed or imposed by the Tribunal, the approval of the Unsecured Creditors of the Transferor Company be and is hereby accorded to the proposed Scheme of Amalgamation between Zuari Cement Limited and Sitapuram Power Limited and their respective Shareholders.

**RESOLVED FURTHER THAT** the Board of Directors of the Transferor Company be and are hereby authorized to do and perform all such acts, deeds, matters and things, as may be considered

requisite, desirable, appropriate or necessary to give effect to this resolution and effectively implement the arrangements embodied in the Scheme and to accept such modification, amendments, limitations and conditions, if any, which may be required and/or imposed by the Tribunal and/or any other Authority(ies) while sanctioning the Scheme or by any authority under the law, or as may be required for the purpose of resolving any doubt or difficulties that may arise in giving effect to the Scheme, as the Board may deem fit and proper.”
